## MINUTES OF THE EXTRAORDINARY PARISH COUNCIL MEETING HELD ON TUESDAY 14 APRIL 2026 AT 7.30PM AT CHURCH HOUSE, HIGH STREET, ADDERBURY

**147/25 Apologies** – Councillor Mark Gerold submitted his apologies because he was on holiday.

**Resolved** that the apologies from Councillor Mark Gerold and Oliver Ighani be accepted and the absences authorised.

**Resolved** that:

- 1) the draft Adderbury Neighbourhood Plan be approved;
- 2) delegated authority be given to Clerk, in consultation with the Chairman to make any minor amendments to the Plan before the start of the Regulation 14 consultation; and
- 3) the Plan be progressed to the Regulation 14 consultation.
